1. Introduction

- 1.1. LJ welcomed everyone and thanked the group for attending.
- 1.2. Introductions to members of the project team were made.

2. Progress of works

- 2.1. The Multiplex team presented an update on the progress of the works taking place on the former Ludgate House site

3. Previous Minutes / Actions

- 3.1. LJ ran through the minutes and actions from the previous CLG meeting on 22nd April 2021.
- 3.2. One local resident started by noting that they find CLG meetings very interesting and professional. The same resident was keen to understand more about the installation of the façade panels on Building 3 as they were under the impression the installation would be quicker. MP explained that reason the installation is taking longer than expected is due to issues with the production of the panels and getting them to site. MP explained that they hope to have this issues resolved shortly so installation can be progressed.
- 3.3. The same resident was also keen to understand more about the pedestrian movements across the masterplan and asked if there was a website where this information can be found. LJ explained that this information is not currently on the project website but will be happy to share it with the group. **ACTION** LJ to share pedestrian movement plan with the group in advance of the next CLG meeting.
- 3.4. VC asked about the format of the regular newsletter and if the project team had received any feedback from the community on their content. JT explained that the team are yet to receive any feedback on the newsletter and that local residents have complimentary of the amount of information included at the CLG meetings. JT clarified that the team would welcome any feedback on the newsletter.

JT explained that the CLG is still taking place virtually and will continue to do so until restrictions allow.
